### How we use the information that you have given:

# This information is kept for the purpose of communicating with shareholders on matters relating to the Company and to comply with the covenants covering the estate as well as the Company's legal and regulatory requirements as follows:

Send you an invoice for the annual maintenance payment due to the Company

Send you regular newsletters, information and updates about the Company

A shareholder's details will **not** be shared with any third party save for the Company solicitors, Company accountants, Companies House, government agencies, the courts and agents for the company.

A shareholder's details will not be released to any other third party without the express consent of that shareholder.

If you have opted to receive information by email your contact details will be stored on our website server. All information stored on the server is encrypted and protected

Information regarding shareholders held by the Company's accountants and solicitors will be held by those organisations for the length of time specified in their own policies

Our mailing list is securely held on a protected database. We keep the information that you provide until you cease to be a shareholder of the Company

# Your data protection rights

### Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

**Your right to rectification** - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.
